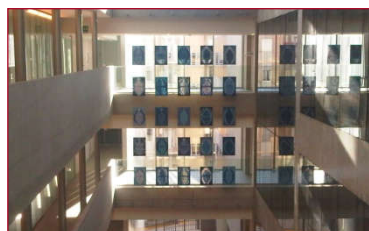

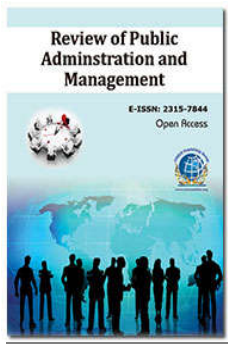

Reason: «The paper deals with the theme of craftsmanship and, more generally, of micro-enterprises in the development of the economic system, its criticalities and growth prospects. The research highlights the difficulties that the craft meets in the face of the shortening of the reaction times imposed by the market and the expansion of the geographical spaces of competition. The research makes a careful evaluation of the three dimensions that can contribute and facilitate the craft enterprise: i) setting up an incentive system for artisan entrepreneurship to work together to compete; ii) change the incentive system, which must support network interventions rather than individual projects; and iii) the existence of a strong industrial project and an authoritative leadership, that must be combined with the recognition of the need for aggregative forms between companies».
